Notes on Application Form

1. All club names require to be approved as part of the membership application process.
2. There are six defined geographical Areas within Scotland : Edinburgh; Glasgow North, Glasgow South, Scottish Borders, Midlands and the North. Clubs based outside the boundaries of Scotland are classified as belonging to the Scottish Exiles Area.
3. Please provide full contact details of three club officials. The primary club contact should be described as being the Club Secretary.
4. We believe that all but the most informal of clubs should have a constitution. Advice on club constitutions is available from the **sportscotland** website.
5. It is mandatory that all clubs (other than armed service clubs) complete a Club Accident Insurance Proposal Form. A copy of the Form is available from the Scottish Rugby Website.
6. Other than applications from Scottish Exile clubs, all applications require to be supported by letters of support from two Full Member clubs in the same geographical Area as the club. Scottish Exile clubs applications may be supported by any two Full Member clubs. Assistance can be provided in identifying appropriate supporting clubs if required.
7. The application should be signed and dated by one of the Club Officials identified on the form.
